Description of Event

The Trial will be open to affiliated members of the ACU and will be run in accordance with the National Sporting Code, the standing regulations for Trials of the Auto Cycle Union (Ltd), the following supplementary regulations and any final instructions to riders that may be issued on the day of the event. The trial will be run under non-stop rules as per TSR-22B.

This event follows 2 optional training days, at the same venue, for youth and adults, organised by ACU Western's Youth Development Squad and it will be a chance to try their newfound skills against other riders in a full event. Camping and accommodation is available over the 3 days. More details on the club's website.

Coldbrook Farm, Longtown, Herefordshire. The start will be signposted off the A465 Abergavenny to Hereford road at Pandy.

Conducted Youth routes:

Standard Route with Red & Blue markers.

Expert variation marked with pairs of white markers.

Entries

Trainees will have an entry space reserved for them in the main trial and will get a full refund of their pre-paid entry should they not be able to ride for whatever reason (So you can get the paperwork done now with no fear.)

Entry Fee: £15. (£10 Yth) (**£20/£15 Yth, after closing date!**) Cheques made payable to 'West Glos & Dean Forest MCC.'

Entries are limited to 100 by order of receipt and will close Thursday 26th July 18:00 or when full. Confirmation of entry will be displayed on the club's website or posted if an extra SAE is provided.

Entry fees may only be returned in the event of cancellation or postponement. Refunds may require a small administration cost. The organisers reserve the right to refuse entry.

Start time

Starts 10:30am (Remember you need to be signed on 30 mins prior to your start time.)

Sections

Standard trials marking will be used throughout - 0, 1, 2, 3, 5. Trial is a no-stopping trial (TSR22B).

Disciplinary Action

Riders are reminded that any abusive or threatening behaviour towards officials, including harassment of observers, is in breach of ACU 11.01.7. This also applies to any member of the rider's entourage, including parents and guardians of youth riders.

Entry declaration: I the undersigned apply to enter the event described above and in consideration thereof:-

- I hereby declare that I have had the opportunity to read, and that I understand the National Sporting Code of the ACU, the ACU Standing Regulations, such Supplementary Regulations as have or may be issued for the event, and agree to be bound by them.
